The ornamental design for a capsule window, as shown and described.

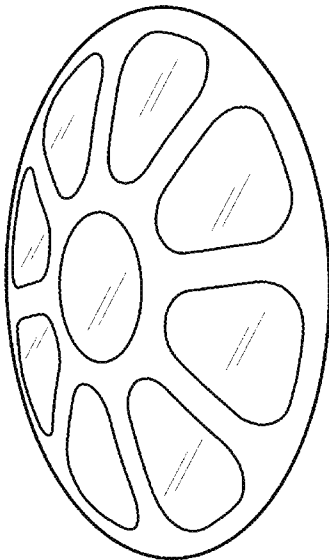
DESCRIPTION

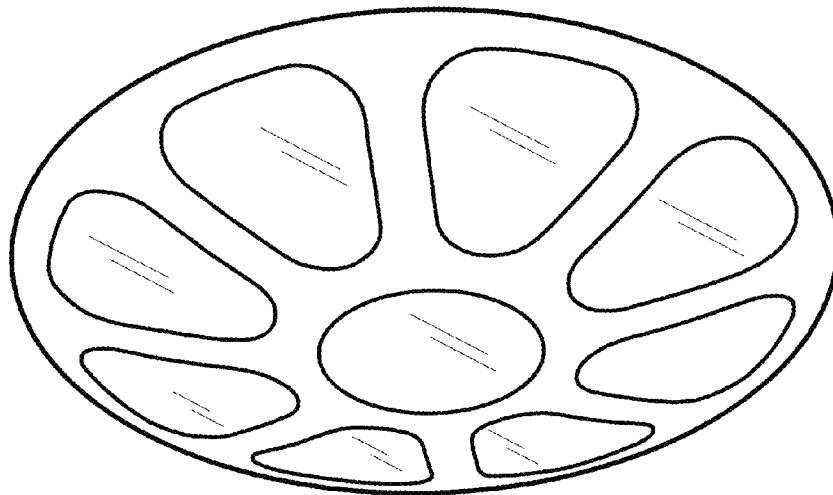

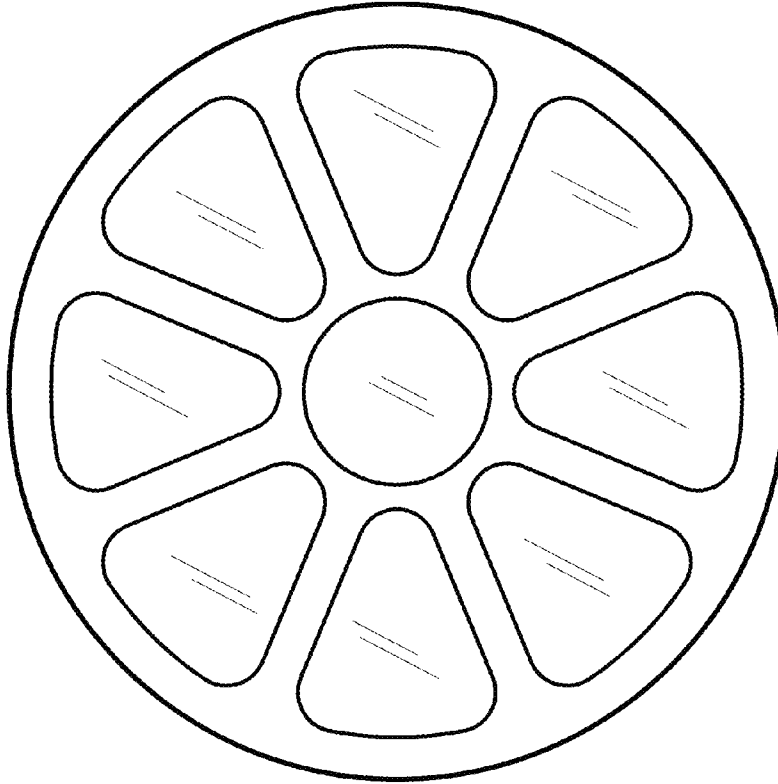
